As Seventy-Five State Street launches its tenth Annual Appeal, all those associated with our senior living community wish to express deep appreciation for the generosity that has been shown by so many supporters in past years. Those donations have enabled us to purchase important items that could not be funded in our annual budgets. Items include computers for residents' use, a new projector for our theater, a large wooden deck on our south patio, a new piano, a whirlpool tub system, new lounge furniture, an upgraded sound system for programs and an additional accessible ramp connecting to our Rose Garden. Interesting lecturers speaking on topics pertinent to residents have also been funded by Annual Appeal gifts. Our transportation program for residents has been greatly enhanced in years when this funding was added to our new van campaign and to our fundraising effort for a new courtesy car.

At the close of 2016, Annual Appeal gifts of nearly \$14,000.00 were combined with a generous grant from The Eunice Frye Home Foundation. This funding allows us to totally renovate our beauty salon. Upgrades to the electrical, plumbing, heating and air conditioning systems have been completed. New equipment, including handicapped accessible salon chairs and sinks, is currently being installed. Upon completion, the salon will have a large new window, new flooring and freshly painted walls and ceiling. Anticipation is high! The grand opening of our new salon is sure to be an exciting event at Seventy-Five State Street.

Gifts to our 2017 Annual Appeal will be designated for projects that improve our outdoor spaces for all to enjoy. Such items as patio furniture, canvas tenting and better signage in our parking areas are high on a list of requests and suggestions.
